The undersigned further guarantees full payment of any debts of Dealer to Auction, Including any issued collections such by a Dealer of any of Dealer’s representatives, together with any loss or expense incurred by Auction in collecting of checks, drafts attempting to debt, including attorney fees. The undersigned acknowledges that Auction shall have the right to refuse the transact business with Dealer, to mortify or release any and all collateral security, to extend or change time of payment and to settle or compromise with Dealer without notice to the undersigned and without discharging or affecting the liability of the undersigned hereunder. This guaranty is to be continuing guaranty and the undersigned hereby waives notice of acceptance of this guaranty and presentment, demand protest, and notice of non-payment or dishonor. The undersigned shall be liable as principle debtor and nor merely as surety and assignment in favor of creditors of Dealer shall not effect bankruptcy and or the undersigned, and shall ensure to the benefit of Auction, its successors, assigns and subrogates, where there is more enforceability of this agreement. The instrument shall bind the respective heirs, executors, administrators, and access that one signatory to the agreement each signatory shall be jointly and severally liable under this agreement. RETURN VEHICLE POLICY

1. All vehicles must be approved for return 24 hours in advance by calling Orlando Auto Auction (407-299-3904).
2. When an approval for return is given, the buyer has 48 hours to return the vehicle unless other arrangements have been made.
3. A vehicle left on the lot without proper notification is not considered a returned unit, and is still the buyer's responsibility until the proper auction personnel are informed.
4. Buyer's have seven (7) days to advise Orlando Auto Auction of unannounced frame damage.
5. Any vehicle sold for \$2000 or above with unannounced frame damage is eligible for arbitration
6. Any vehicle sold for \$1000 and under is sold "AS IS", NO ARBITRATION- regardless of lights.
7. Orlando Auto Auction assumes no responsibility for reimbursements of funds on a return prior to the return of the title.
8. If seller has been issued a check, reimbursement to the Auction must be made immediately.
9. The vehicle must be returned in the same condition as when purchased.
